## **PUBLIC POLICY ANALYSIS FOR HIGHER EDUCATION PROFESSIONALS (CONCEPT AND DRAFT AGENDA)**

### **Overall Objectives**

The key objective of the program is to equip professionals in higher education with a set of modern, effective, "hands-on" public policy analysis tools, which will enable them to formulate well-designed policies with high chances of being adopted in the decision-making process. The main focus is on a sequence of stages in the policy making cycle and in applying the new concepts to a study cases in education, including at least one study case brought forward by each participant.

The learning steps from problem definition, stakeholder analysis, options analysis to cost effectiveness will offer the participants an approach for real situations they deal with. Through case studies and group activities, participants will also reflect, analytically, on the limitations of handbook tools in real life situations and how these can be overcome through reframing the issues at stake.

In order to tie this workshop to the learning objectives of the policy manual, the separate Public Policy Handbook (Manual) in Education will be used prior to the date of the workshop, as preparative background material (two chapters). Using the draft of the handbook, participants will present a public policy problem in the format recommended and will highlight areas that they want to improve on during the workshop.

The working languages of the program are Romania and English.

### **Participants**

40 experts, selected through a closed call for applications, from national bodies involved in public policy formulation, analysis and evaluation (MEN, UEFISCDI, ARACIS, CNS, ANC).
